Please note that effective October 3, 2016, all insurance information is required to be submitted online to the UIIA office so that it can be processed immediately and expedite the reinstatement of your company's UIIA participation. If your agent is not yet registered to submit insurance online, they should do so as soon as possible by going to [www.uiia.org/insurance/ia\\_login.php](http://www.uiia.org/insurance/ia_login.php) and clicking on "**New Member – First Time Agents**".
